NOW THIS DEED WITNESSES that for the purpose of effectuating the desire, the settlor has irrovocably transferred the said sum of Rs. 10000/- to the trustees (the transfer whereof, the trustees do and each of them do hereby admit and acknowledge being subservient to the uses and trusts hereinafter mentioned :-

- 1. The name of the Trust shall be WOMEN'S EDUCATION TRUST; KAITHAL, in short to be called as WE.
- 2. The office of the Trust shall be situated at STEVER OAK, Kurukshetra Road, Kaithal but the Boand of Trustees shall have the option to shift to any other place as and then they so desire.
- 3. Objects :- The Trust has been created for charitable purposes and the objects of the Trust shall include: Fur

(i) To show the females the way to 'Women Empowerment'. This objective is to be achieved through education of females all kinds of education, school, college, university. All kinds of technical education including computers and other vocational education. In the field of Health Education, Health Care, Nutritious Food and Family Planning will be of inportance.

(ii) To improve the aesthetic sense of the females they will be trained in the field of art, culture and spiritualism.

(v) To start schools in villages/cities to provide quality education.

(vi) To take all such steps so as to encourage parents to send their female wards to schools/college for proper education.
(vii) To encourage well-to-do citizens to adopt one female child.

Adopt here means paying the educational expenses of the adopted child. (viii) To provide books, bags, uniform and other education related material to needy children and institutions.

(ix) To provide scholarships to the children.

(x) To open schools for handicaped and mentally deficient children.

(xi) To conduct seminars/work shops and arrange special tution/ trainning classes for students.

(xii) To render assistance to poor patients by providing medicines etc, provisions of health care, preventive intelical services including vaccination.

(xiii) Provision of out door dispensary and also to run mobile medical services.

(xiv) To provide all kinds of legal help, assistance, guidance to the females in destitute.

(xv) To provide moneatry assistance and social services in case of natural calamities.

(xvi) To help other trusts having their objects similar to the objects of this trust.

(xvii) To carry such activities as are incidental and conducive to the objects above specified from time to time.

(xviii) The objects of the Trust shall not include objects involing, carrying on any activity for profit within the meaning Income Tax Act, 1961.

4. On execution of this deed the trustees shall take charge of the said sum of Rs. 10000/- (Rupees Ten Thousand Only) and it will be the corpus of fixed property of the trust, and it shall be not disposed off or subjected to any kind of charge for the purpose of meeting the expenses for carying out the objects of the trust or any other purpose unless otherwise resolved by the Board of Trustees.

5. The trustees shall stand possessed of the said amount and such other properties (both movable and immovable) as may be acquired from time to time by the trust by purchase, exchange, grant, subscription, endowment, donation, contribution or in any manner whatsoever (all of which shall be designated as 'The trust properties' on the trust herein mentioned).

6. The trustees shall have power from time to time to increase or decrease the corpus of fixed property of the trust and this corpus will not be valid in contravention of Clause 4 hereinabove.

7. The trustees shall have power to accept donations either in cash or movable properties either with or without and specific conditions at attached to it provided it did not contravene Clause 3 hereinabove.

8. It shall be competent for the trustees from time to time to frame, make and enforce all such rules, regulations and/or bye- laws not inconsistant with the express provisions of this trust as the trustees may deem proper for securing and facilitating the administration and management in detail of the various departments relating to the activities and affairs of the trust, and for convening, conducting and regulation the meetings of the trustees and for appointing sub-committees and generally for the management and administration of the trust, estate and also from time to time to repeal, alter, amend, rescind or add to all such rules, regulations and bye-laws and also to pass resolutions in connection with all or any of the said matters at their meeting.

The trustees shall have power and authority to appoint or engage and at their discretion remove, dismiss or suspend one or more secretaries, treasurers, supervisors, cashiers, accountant, clerks, chowkidars, attendants, servants and other officials or employees and persons in permanent temporary or special servicies in connection with the work of the trust, trust estate, trust funds, and trust properties as they may from time to time think fit and to determine their powers and duties and fix their salaries, bonus, or emoluments and to require security in suchristing instance and such amounts as the trustees may think fit. The trustees shall also have power to form and maintain provident funds, gratuity funds, personal and other funds for any employee and make rules and regulations regarding the

The trustees shall have power in general to acquire all things 10. and do all acts necessary to carry out the objects of the trust.

The trustees shall be entitled to reimburse themselves, out 11. of the trust estate, all expenses incurred in connection with trust or powers therein or in carrying out the trust; its subjects and affairs or the realisation, preservation or benefit of the trust properties. The trustees shall be entitled to be indemnified by the trust properties against the consquences of all lawful acts done by the trustees in the course of and discharge of their duties as the trustees of these trusts and all costs, charges and expenses thereof.

Trustees shall not be entitled to any remuneration and shall 12. work in an honorary capacity. They shall, however, be entitled to receive the out-of-pocket expenses // incurred by them in the course of discharging the trust.

The trust shall be governed by a board of trustees, 13. The Board of trustees shall consist of all the trustices, the number of which 58) shall always be not less then four and not more than eleven. The trustees may elect or nominate one of them as the managing 14. trustees and also one of them as Chairman of the Board of trustees, The Managing trustee may be appointed for any period of time. The first Managing trustee, will be Dr. Sonali Chaudhry for her life time. The trustees may at any time invite and receive or without 15. such invitation receive any voluntary contribution either from the settlor or from any othere person or persons by way of donation, legacy or otherwise. All such contribution shall be treated as Principalorming part of the trust fund being the subject matter of the new Silver Onkelsentsions Stand absolute discretion to decide whether they should Kaithal 126222 (Mar 102) accept any such contribution and they shall at all Cont.....

times be at liberty to refuse any contribution without giving any reason for such refusal.

16. The Board of Trustees is hereby authorised and empowered to nominate any other person as trustee as long as the trustee do not exceed then eleven in numbers.

17. The trustees shall have power to deposit the trust money or any portion thereof in any nationalised bank or banks either by way of fixed deposit or in current account or in saving account jointly by two trustees one of whom shall also managing trustee.

13. The trustee shall also have powers to convert and got the trust property and/or to vary the investments for the time being, and to invest and keep invested, the trust properties either in the purchase or mortgage of immovable properties or in shares, debentures, or other securities and investments whether authorised by the Indian Trusts Act, or not to alter, vary or transpose such investments from time to time as the trustees shall in their absolute discretion think fit. Provided, however that accumulations of the Income of the Trust properties in respect of which notice has been given to the Income Tax Office under section 11(2) of the Income Tax Act, 1961, shall only be invested in accordance with clause (b) of sub section (2) of section 11 of the Act.

19. For the purpose of carrying out the objects of the trust, the trustees shall have power to acquire by purchase or on lease or otherwise any immovable properties of any tenure and in case of vacant land the trustees shall be at liberty to creat buildings thereon and to do all acts necessary and incidental thereto.

20. It shall be lawful for the trustees to pull down, renovate, rebuild alter, adopt, improve, add to, develop or repair any immovable property comprised in the trust properties and to extend thereon such many out of the trust fund or the income thereof as they may think fit.

21. The trustees shall be entitled to enter in agreements or convenants with the owners of or persons entitled to or intrested in any other properties and to raise funds by way of loans.

It shall be lawful and competent for the managing trustee in 24. his/her discretion to make donations from the trust properties and/or spend the money of the trust in his/her discretion in any other manner to carry out the objects of the trust but not in contravention of clause 3 hereinabove. Provided, however, that the board of trustee shall be informed of the same in the meeting held immediately thereafter.

The entire control, regulation, management, application and 25. administration of the trust properties whether capital or Income, rent, intrest, profit or any kind shall be at the discretion of the trustees.

26. Every, power, authority of discretion conferred upon the trustees shall be exercised or signified either by some instrument in writting to be signed by all the trustees or such of them as may be present or by the resolution ot the trustees or such of them as may be present there and vote at any meeting of the trustees.

27. In case of difference of opinion arising among the trustees and in all matters wherein the trustees shall have discretionery power, the opinion of the majority of the trustees present and voting shall prevail and be binding on the majority as well as on those trustees who may not have voted, and if the trustees shall be equally divided in opinion, the matter shall be decided according to the casting vote of the chairman.

The meetin of the board of trustees shall be held at least once in a year but any number of other meeting may be held as and 29.

A minute book shall be kept by the trustees . Minutes of the entry into office of every new trustee and of all proceedings of the meetings of the Board of trustees shall be entered in the minute book and shall be signed by the chairman of the meeting either at the conclusion thereof of at the next meeting or when they shall have been fully comprised.

Proper and regular books of accounts of all receipts and expend-30. iture of the trust shall be maintained by the trustees either in the Hindi Language or in English or partlyin Hindi and part in English. On the 31st day of March every Year a general account shall be taken of all the assets and liabilities of the trust and and Income and Expenditure account for the whole year and a balance-sheet as on 31st March shall be prepared and shall be passed by the trustees The accounts of the trust shall be audited annually by a chartered accountant appointed by the trustees for the purposes.

In case of death, inability, resignation or refusal on the part 32. of a any trustee a to act as such trustee, the remaining trustees shall be entitled to nominate any other person they may think fit and proper to act as trustee in place of the trustee so dying, refusing to act or being unable to act, provided that the trustee so appointed will have the same powers and rights as if he was originally appointed trustee under these presents.
